House Issues Aired With Dean Caprio

On April 18th and 19th, Assistant Dean of Students Joseph Caprio arranged for each fraternity on campus to hold a meeting of representative members in the convention facilities of the American Management Association just outside Hamilton.

The purpose of the meeting was for each fraternity's members to consider and discuss issues they thought particularly relevant to their house. It was thought that the atmosphere of the AMA would lend a better perspective for these discussions.

Meeting for DKE were seniors Dave Lake, Pete Treichler and John Lindstrom, juniors Chris Manno, John Hoff, and Jim Richards, and freshmen Dave McKenzie, Robb Ries, and Conrad Thrane.

The discussion centered around the image of the house and what should be done to prevent a lapse back into the type of house atmosphere that led to the suspension 18 months ago. The overall opinion was that there was no cause to fear such a relapse, and that as soon as the house is back on full standing with the administration, any evil myths the administration and student body believe regarding the house and the monsters inhabiting it will quickly be forgotten. As a matter of fact, Joe Caprio scrawled about two dozen sayings on the blackboard all to the effect that time heals all wounds. Let us hope that is the case.

The only other topic of real note that was discussed was the matter of joining the Fraternity Management Association's cooperative, an organization which primarily buys food in large quantity. It was unanimously decided by the members at the

Open the Temple? Undergraduates Say No

There is currently a drive on the part of some members of the alumni corporation to open our Temple to the general public. Letters regarding the choices of the alumni corporation have been sent to all Mu alumni. We, the brothers presently residing in the house, feel that our opinion should also be made clear. We have unanimously voted down the proposal to open to the public. We see this proposal as tantamount to the disruption of our unity.

Originally the proposal was generated by the alumni as a response to the low position of esteem in which Mu DKE was held last year at Colgate. However, there has been a pleasing reversal of student and administrative opinion. Consequently, the DKE house no longer has to be degradingly servile in its actions.

We, as undergraduates who are *currently* in touch with University sentiment, feel that to open the Temple to the public is unnecessary and would only serve to disrupt the present balance and strength of the Mu DKE community.
