Undergraduate Report

The 1995-96 academic year was a prosperous and eventful one at 110 Broad St. In the fall, the House welcomed the 139th class of Mu of DKE. The 139th is a diverse group of twenty-two young men, involved in aspects of the Colgate community. The sophomore group has members on the varsity baseball, football, hockey, swimming, and lacrosse teams. Colgate organizations Colgate 13, such as Resolutions, CCAC, and Student Association are represented by the new delegation. The new class also carries a strong academic record, thus enhancing the presence of the fraternity on the hill.

As for the rest of the brotherhood. things continue to be successful. DKE brothers continue to play important roles in varsity sports, club sports, Colgate student organizations, and campus affairs, and the House is in very good position to retain its title of Intramural Sports Champion. DKE remains involved philanthropic and community affairs. The House sponsored a Red Cross blood drive in the spring, and last Halloween the brothers put together a spectacular haunted house at the Pierce Memorial for the youngsters of the town to enjoy.






FOR GALLANTRY IN ACTION

Through the efforts of Denny Babcock '44, Joe De Bragga '43, Bob Bentley '44 and other alumni we will honor our brothers who made the supreme sacrifice during World War II. We have been given the medals awarded to Paul MacDonald, Jr, 2/Lt USMCR, who was killed in action in Tinian on August 1, 1944. These include his Silver Star awarded for conspicuous gallantry and intrepidity in action against the Japanese forces on Tinian, Marianas Islands while attached to the 3d Battalion, 8th Marines, 2d Marine Division. An appropriate display honoring all brothers killed in action will become part of our archives and placed on display.

Please check your attics, your basements, your homes, your files for material which will add to the history of Mu. Brother Blackmore has been able to acquire a number of Sals, but we need to fill in the vacant years. Gris Hurlbert has sent us his father's files. Report from the Alumni Corporation

- 1. Financial Condition: I am pleased to report that all taxes and government documentation are now up to date. When I took over this responsibility approximately two years ago, we were two years behind. With the able assistance of our local accounting firm in Syracuse we have been able to catch up. You will appreciate that with the smaller numbers living in the House, we have enforced to undertake certain fiscal changes. Jo Fenner has willingly assisted with the result that her costs have been reduced by about 20% and a very favorable oil arrangement has been reached with the local provider at a cost that is more favorable than the FSMA has been able to negotiate. If the undergraduates are successful again next year in securing a goodsized class, we should be in position to begin a capital saving program again. In the meantime, I am pleased to advise the Foundation that we are in a position to make our first payment since the Foundation provided us with financial assistance.
- 2. The Undergraduate Brotherhood:
 Despite the difficult situation of a
 recent return to campus and a
 significant decrease in interest
 toward fraternities last year, the
 undergraduates were able to pledge
 a very strong class of 22. I was

recently advised by Joe Caprio that, in his opinion, we presently have the strongest group of young men in the Colgate fraternity system.

Over the last two months I have seen a marked improvement in the undergraduate responses to the kinds of issues that are bound to occur on an annual basis. I want to publicly take this opportunity to thank them, and, more particularly, thank David Keyt for stick handling through some delicate communication issues. The foundation has been laid for continuing constructive communication in the future between the undergraduates and the alumni.

3. The Pierce Memorial - Without a doubt, the physical plant continues to be the best on campus, despite extensive expenditures by other Houses to upgrade their buildings. Despite our financial crunch we were able to find sufficient funds last summer to repaint the entire outside and inside of the building. Apart from the day-to-day items that regularly occur, there is presently only one significant project that must be completed within the next five years. I am referring to the heating system, which will cost an estimated \$25,000 to \$50,000 to upgrade. We simply don't have the funds at this time to go forward with this project, but I am hopeful that we will be able to go forward during the summer of 1997, if we have another good class in the spring of that year.

4. Foundation and Corporation Interaction - I am pleased to be able to say that the level and quality of communication is as good as it has ever been between the Foundation and the Corporation. John and I have talked at least every two weeks for some time. While I would have preferred to speak more often, I was unable to get John off the golf course. With his current back problems, I should now be able to achieve my goal. But seriously, this level of communication needs to continue into the future.

In conclusion, I want to say that the ship has been steadied, it's on course. Our goals are clear and with another good class next year, we should be in good financial shape for the foreseeable future.









Dear Brother Wilson:

I was sorry you were unable to attend this year's Blackmore Scholarship Dinner. Despite your absence, the event was a success. I personally would like to thank you for your part in bestowing upon me the honor of receiving the Gordon P. Lovell Scholarship. I hope that my efforts have increased the awareness of the problems that are associated with both alcohol and drug abuse.

There is an increased awareness of the problems both within the House and at Colgate. I have talked with Mark McKay '91 and am hopeful that he will be able to visit and speak with us before the end of the semester. Additionally, Joe Bliss '40 and Steve Bajus '73 have offered their support.

The most interesting news I have to relay concerns our plans to initiate a lecture series with Colgate University. The administration was very open to the idea of a seminar on alcohol and drug abuse sponsored by the DKE House. I have been referred to an organization called Freedom from Chemical Dependency. The group consists of thirty individuals who are former alcoholics or drug abusers and sends its members to schools around the country in an attempt to educate the younger generation. They do request a fee of \$500 per day plus expenses.

I understand that with the circumstances as they are that funds are scarce. I have not as yet discussed the possible means of payment with the University, but for something of this nature, they may be willing to aid in the costs and make it a joint sponsorship. I would appreciate your input so that we can hopefully hold the event in April.
