News From the Alumni Corporation and the Undergraduates

This has been an excellent year for the undergraduates and the Alumni Corporation. Financially, we are in the best position we have seen for a number of years, in large part due to the efforts of the undergraduates in attracting new members to the House. As you can appreciate, the significant determinative factor for our financial health surrounds the number of new members we are able to attract. The quality of their effort and the quality of the undergraduates themselves has greatly assisted in reaching our target of 25. This has improved our financial health to the point where the Alumni Corporation expects to have reduced its indebtedness to the Foundation by \$30,000 before Reunion Weekend.

On a special note, we have now completed The Computer Room, which is located at the top of the stairs on the first floor where the library and telephone room used to be. It is outfitted with the latest in computer technology and is fully integrated with the Colgate University system, including the internet. We are proud to say that it is the first facility of its kind in any of the fraternity or sorority facilities at Colgate. The proof of the value of this project lies in the fact the equipment is constantly in use by the undergraduates. We all want to thank John Wilson and John Robinson for their inspiration for the project, together with their technical and financial support. This new facility reconfirms our commitment to the development of all aspects of the undergraduate DKEs at Colgate. Colgate has given us high praise for this initiative.

In terms of continuing improvements to the physical plant, the kitchen was completely renovated last summer, including a new roof, and we are presently undertaking a facelift of the living room/foyer area which we hope to have completed by Reunion Weekend. This project will include improvements to the fireplace, a return to the wooden floor in the living room, and refinishing the marble in the foyer. Improvements to the exterior of the House will include the installation of a sprinkler system early this summer.

In the area of academics, the undergraduates continue to excel with three Phi Beta Kappas (Jim Barlow, Paulo Figueiredo, and Mayank Singh), and the House had the highest GPA for the Greek system in the first semester. The recent Blackmore Scholarship Dinner was a huge success again with attendees including George Werntz, John Hubbard, and Phil Wolfenden. In addition, there were a number of representatives from the Colgate administration and faculty. We want to take this opportunity to thank Bob Blackmore for his continuing support of scholarship at the House.

In the area of extra-curricular activities, the House continues to excel with members of varsity sports teams including football, swimming, golf, and lacrosse. We have recently been crowned the Intramural Champions, and as we go to print with the Yon Clarion Bell, the DKE A team is playing the DKE B team for the intramural baseball championship. We also have members of the Colgate 13, the Resolutions, and the founders of Club Surfing. John Guido founded the Pre-Law Society and is its first president. We have three members of the Newman Community Board and the co-president of the Colgate Community Affairs Committee (the organization that organizes the social events at Colgate). Finally, two of the executive members of the Inter-Fraternity Sorority Council are DKEs, Andrew Coons and Bob Vidoyi, who are the New Member Education and Philanthropic Chairs respectively.

Speaking of philanthropy, the House hosted a hugely successful blood donor drive and again took time out at Halloween to put together the Haunted House Evening for the children of Hamilton.

In closing, the relationship between the undergraduates and the Alumni Corporation continues to be positive and strong. We don't always agree, but the process of reaching consensus has become much more constructive in the recent past.
