## Introducing two great delegations

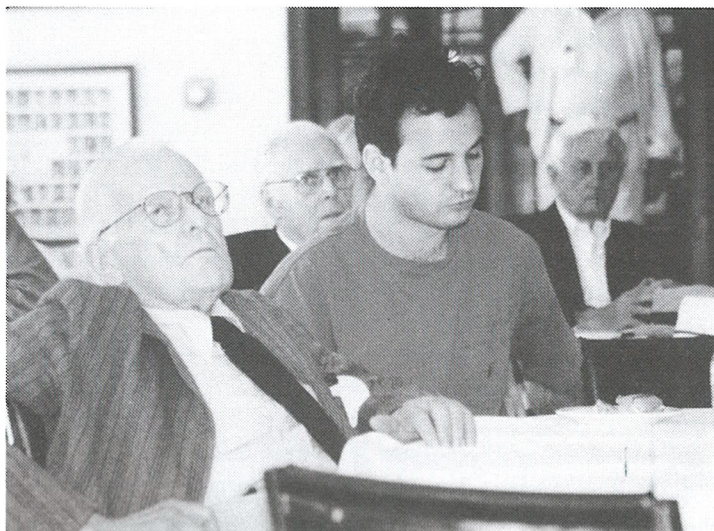

In addition to the gorgeous granite replica of our beloved pin in front of the fireplace, the rest of the living room floor is made of 3/4-inch oak hardwood. All of the Alumni who have returned to the Pierce Memorial have been extremely satisfied with the changes. We are forever grateful.

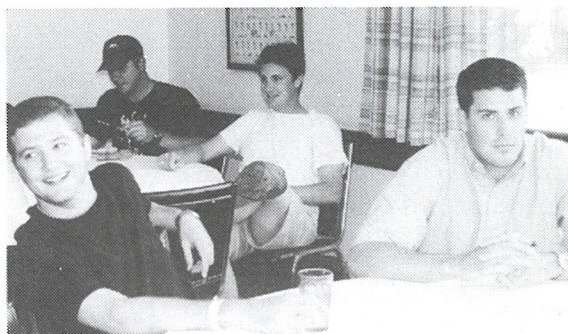

Relations between Mu and the rest of Delta Kappa Epsilon have been strengthened. Tom Halley (Mu '73) gave a presentation to the conference about what is happening with the DKE chapter at Hamilton College. I feel very strongly that I learned a lot of necessary information in order to ensure our chapter's safety in the future. I thank those who made this trip possible.

I am very excited to announce that Mu currently has 20 new members looking to be initiated as DKEs. The incoming class

is very strong and has many outstanding individuals who will keep the traditions of DKE going. The Undergraduates are anxiously anticipating a possible training with Outward Bound. Research is being done, but more thanks go to those alumni who thought of such a terrific idea.

On Tuesday, Sept. 15, Alan Berkowitz is being sponsored by Mu to give a presentation to the Colgate body on Sexual Harassment and Sexual Assault. We feel this is a very pertinent topic that needs to be discussed more freely on the Colgate campus. As a main force on campus, the Undergraduates are proud to be leading the cause for men to take the responsibility of ending such issues on campus. Other philanthropic and educational activities being sponsored by DKE this semester include a blood drive, the Haunted House, faculty dinners, a speaker on drugs and alcohol and the Blackmore Scholarship Dinner.

The undergraduate body is made up of many student leaders as well as members of a plethora of activities, such as varsity sports, Second Place Intramurals, CCAC, Information Technology Services, Newman Board Members, Resolutions, Colgate 13, the pre-law society, lifeguards, welcoming and helping the first-year students become acclimated with Colgate and Colgate's Surfing Club. In addition, Mu holds three of eight executive seats on the Inter-Fraternity Council. Our grades are consistently among the highest on campus each semester. We graduated three members of Phi Beta Kappa, and we currently have one member in Konosioni. However, we all hold one thing in common, including with all of you alumni — we are Mu DKEs. This pride is felt through the house and the school very strongly. ### Harassment, assault presentation given

In a meeting with the Dean of Fraternities and Sororities, the Active chapter was asked what positive campus-wide activities we would like to sponsor to fulfill our obligation to the college community. It was mutually agreed upon that one of the greatest needs was better understanding concerning relationships between men and women on campus.

Phil Wolfenden contacted an expert in the field, endorsed by the college, and contracted for his services. He offered two presentations, one for the entire campus and one at a closed session at the Pierce Memorial.

Our cost was \$3,000. All parties involved, particularly Mu undergraduates, felt this venture was of great value. All donations to defray the expense will be greatly appreciated.



## Outward Bound sign of character

Vast changes have been legislated in fraternity rushing at Colgate. For example, an education period has replaced the pledge program. Hazing has been outlawed nationally. We have tried to find something of a positive nature that would build the traditional values of our fraternity to replace our old program.

Phil Wolfenden is currently working on a program with Outward Bound, which would stress loyalty, responsibility and character as stated in The Objects of Delta Kappa Epsilon. The program is fully endorsed by the Dean's office. Russ French got us started a few years ago with a \$ 1,000 donation.

The annual meeting was called to order on Saturday, May 30, 1998, at 9:35 a.m. with approximately 75 Brothers in attendance.

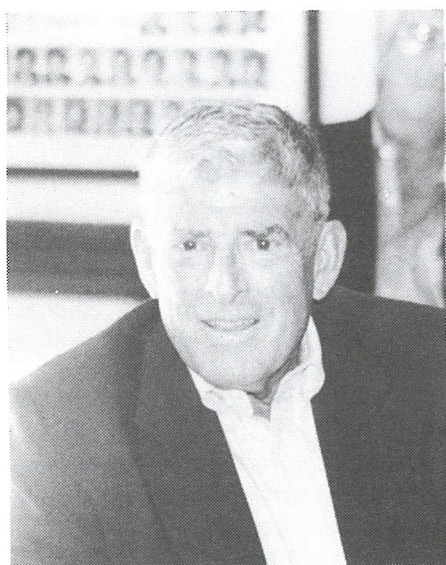
At the meeting, your Chairman reported that Dan Quayle had sent his best wishes to Mu along with an autographed picture purchased earlier by Brother Halley. This picture was

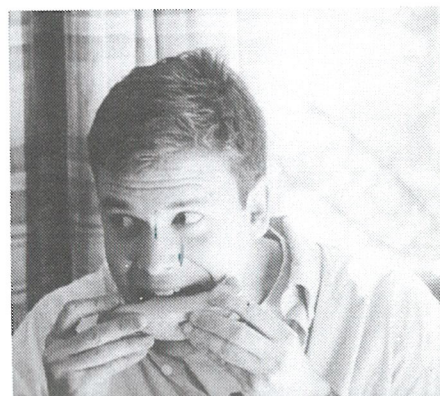
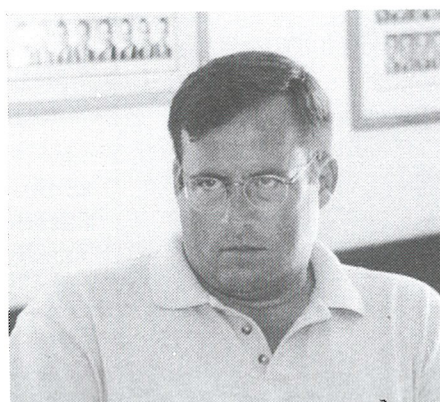
A motion was made, seconded and

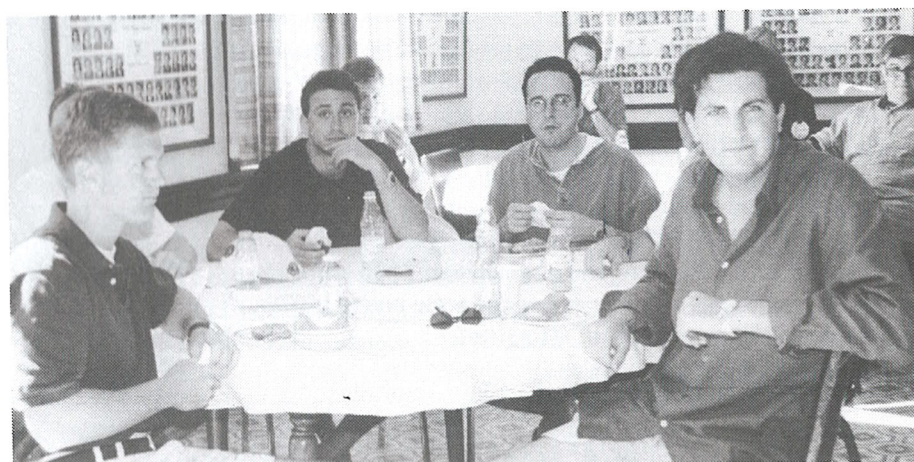
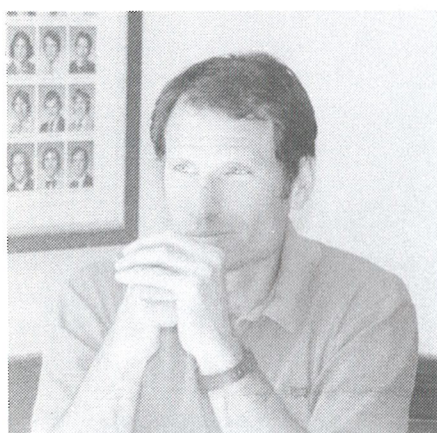
Brother James Rubenstein turned in the keys to The Temple Library and

wishes for its use for the 1998-1999 academic year.

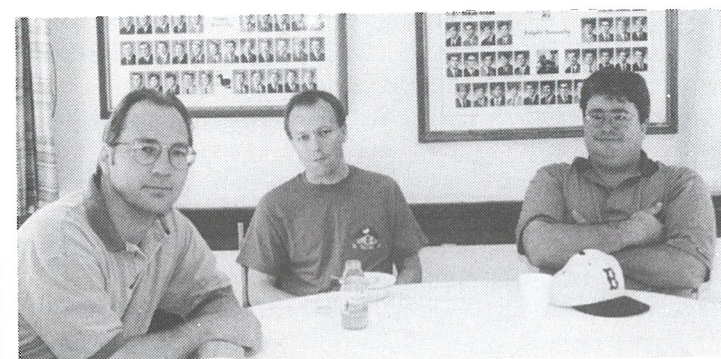

## Peers name Larry Bossidy '57 year's top exec

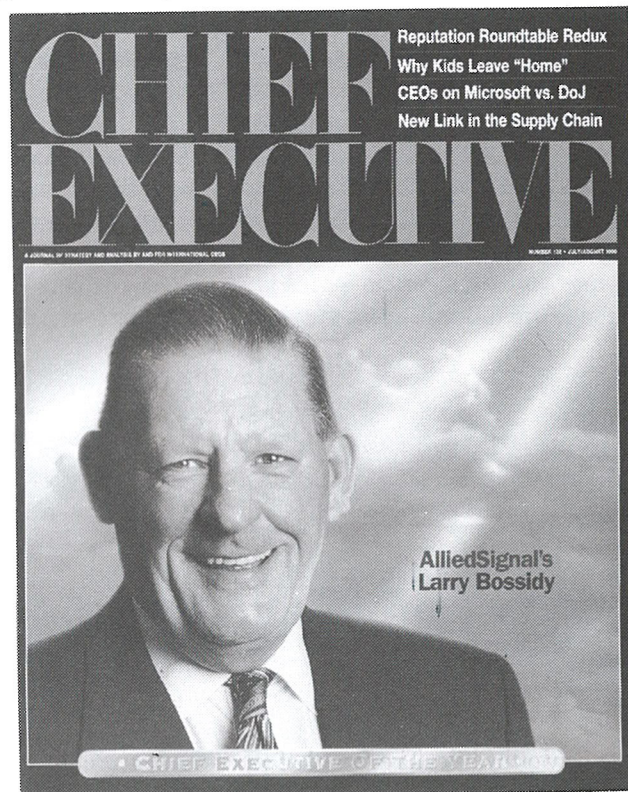
From the selection committee of his peers came the following comments: "Larry's leadership is evident in so many places — shareholder value, revenue growth, productivity and the fact that Allied Signal now ranks among the most admired and best companies to work for."

"His transformation of Allied Signal has been outstanding in every measurable dimension."

## Long-range plans making great achievements

Even though there has been no formally written plan, agreement on goals for our fraternity have long been understood and agreed upon by both The Alumni Corporation Board of Directors and The Foundation Board of Trustees. During the last 10 years we have climbed mountains and cleared insurmountable hurdles.

There have been rocky times. A great deal of work has been invested in our fraternity by many Mu alumni, but if one man should be singled out it would be Phil Wolfenden, president of the Alumni Corp.

Over the last 15 years he has invested more time and effort than anyone could expect. In good times and bad, he has always been there when needed. The Foundation has been in existence now for 10 years. It was set up to support our fraternity, but severely restricted to educational and philanthropic activities.

By funding scholarships, fraternity philanthropy, The Temple Library and educational expenses, Mu is making progress toward our long-term goals.

The leadership has expressed a desire to build Mu into the finest fraternity in the world. Some may smile and some may say our goal is just "whistling Dixie." However, if we continue to make the same progress we have made during the last 10 years, our goal will be achieved.

The Active Chapter is, of course, the key. We have seen great progress in leadership, attitude and responsibility from our undergraduate brothers. Their continued understanding, appreciation and willingness to perform will carry us forward.

The Temple project is completed and paid for. The Alumni Corp.'s finances are in order. They have reduced their debt substantially, while making major

improvements at The Pierce Memorial. When the Foundation has the funds to support the scholarship grants, philanthropic and educational programs, this frees up funds to improve the Pierce Memorial.

During the next few years you will see giant strides in this area as long as the funds are available. If you have wanted to see improvement in The Pierce Memorial in the past and possibly been critical of our progress, now is the time to send your support to Mu.

The Sexual Harassment Presentation, the Extranet site, Outward Bound, the Work-Study scholarship grants would all either be paid for out of current operating funds of the Active Chapter or would not be possible.

Your tax-deductible contributions are very important at this time to take us further down the road toward achieving our goals.



## Report: Alumni Corp. getting the job done

The 1997-'98 school year proved to be very successful for Mu of Delta Kappa Epsilon. We had a strong pledge class of 25, a championship in intramural sports, leadership involved in various campus activities, philanthropic projects like the Haunted House well attended by local kids, continued academic excellence with our GPA near the top in both semesters and mutually positive relations with Colgate University.

A number of significant projects were completed. Firstly, there has been a significant gap in the business side of our operation since Fred Colvin was forced to resign his position. While the job was

getting done, it was not getting done to the Colvin standard, so I cast about a couple of years ago and found an accounting outfit in Ithaca, N.Y., that specializes in the handling of fraternities and sororities throughout the Northeast. Last year was the first full year we used them, and I can assure you that we are getting close to where I want us to be. Everything is pretty much being handled in a timely fashion, and proper financial reporting is now in place.

On the physical plant improvement side, three significant changes took place. I should say to those of you who have not been back to Colgate for some time that the University has done a superlative job of improving just about the entire physical plant on the hill, from brand-new, hotel-like lodgings to a first-rate dining facility. As students cannot pledge a fraternity until their sophomore year now, they get used to this very high standard of living, which forces the fraternity system to keep pace, if it hopes to continue to attract students. Our first change was to install a restaurant quality refrigerator in the dining room, so the Brothers can have access to food 24 hours per day. This has been well-received, as you might have guessed.

Our second project was to replace the carpeting in the living room. After

considering several options, we decided to go with a new, solid-oak floor, which looks fabulous, cleans up much more quickly than the carpeting did and can take much more wear-and-tear. Also, a new section was custom designed for the front of the fireplace, featuring a replica of the Deke pin, utilizing a new computer design technique. We have heard nothing but accolades about the entire project.

Last, but certainly not least, we became the first fraternity to feature its own Information Systems room, including three state-of-the-art computers.

So far this school year, I can report the taking of a class of 20, with whom we are in the final stages of planning for an Outward Bound weekend, which we are convinced will provide a highly constructive team-building experience for all those involved. We have already received some financial support from our alumni for this very worthwhile project, but further assistance would be of great help, as such programs do not come cheaply. Please direct any checks to the Foundation, in care of John Wilson. Our long-range plan is to create an endowment that would be used for this purpose in perpetuity.

Finally, on a personal note, next June will be our 25th reunion. To the members of our class, Barry and I extend our personal invitation to return. Some of you we have seen many times since graduation, while others have done their own thing. Guys, there have been many changes in our lives over these 25 years — jobs, kids, marriages and lots more — but one thing has remained a constant: We are brothers ever friends at heart. Please think seriously about coming back. Bring your family. Colgate puts on wonderful programs for the kids. I know, because I've brought mine many times over the years. Barry or I will be in contact over the next couple of months. We very much hope to see all of you next June.

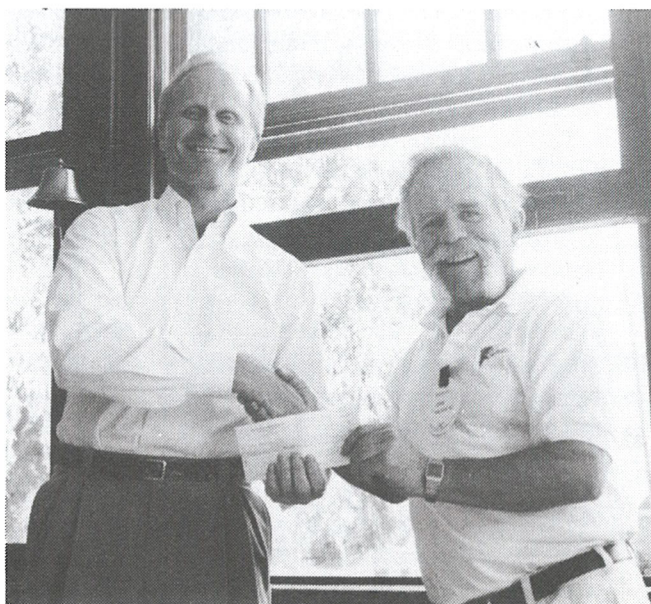
### Active proposes Extranet site

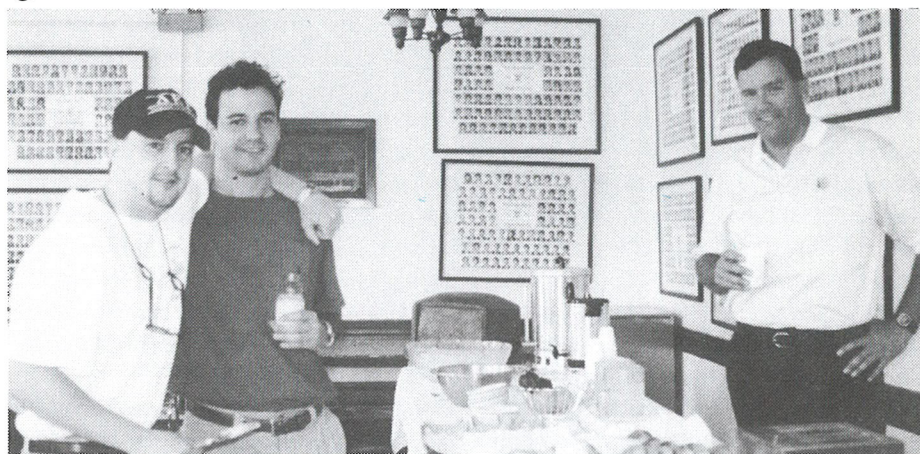

Dear Brothers:

Following is a summary of the project as proposed to Brothers Wilson and Wolfenden. I have offered the services of my company, MeccaDigm L.L.C., to build Mu an Extranet site. The major applications proposed for the site are: a searchable job networking database area, chat rooms for each class, Foundation/Corporation communication areas, educational opportunities for the undergraduates, public relations/marketing Web pages, online Yon Clarion Bell and Undergraduate Reports and internal computer support.

The job networking area will contain a detailed database providing alumni and undergraduates with a valuable resource for job networking and any personal necessities. The database will be constructed to contain files for each Brother. In each file will be unlimited potential for fields of information. The files can contain everything from phone numbers to pictures to detailed descriptions of each person's career. If, for example, you need to find someone who knows architectural CAD, you can search the database for every Brother's file containing anything about that subject. The search function will produce a printable list, along with the capability to e-mail each person directly from the Extranet. The Job Networking Area will contain a Job Openings folder that can be created for Alumni to post positions, requirements and contact information. Also, a resume folder can be created containing any resumes of people in job transition.

The chat rooms solve two problems: Recent graduates can't afford to have long phone conversations, and e-mail is often read by our employers. The chat

rooms, along with bulletin boards, allow Brothers to converse in real time, at no cost, without the worry of their employers reading their personal thoughts and stories. The chat rooms can be arranged by class, city or region of the country. Bulletin boards can be set up so that people in one city can post events or ask questions to each other.

The Foundation/Corporation areas can be designed to solve any communication difficulties that board members encounter. Documents can be stored in a shared and secured area for each member to review and make comments. Chat rooms and bulletin boards can be used to organize tasks or events. In the future, the site could be used for video-conferencing.

The site also functions as a valuable fund-raising tool. Brothers' emotions can be stiffed by taking a Quick Time Virtual Reality tour of the House, accompanied by DKE songs. Potential projects can be prototyped in 3D models to show Brothers what their contributions will be doing for the House. All names of those who have given can be featured on separate pages, or high traffic areas. Sections can be named for those who have contributed the most.

The site presents educational opportunities through the development of new online Undergraduate reports for the

site. New positions can be created to write content for the Weekly/Monthly Undergraduate Reports that will be featured on the site. Philanthropic Events, Academic Achievements and miscellaneous stories can be written to publicize the activities of the Chapter. Videos and/or pictures of Charity events can be posted on the site. These new positions will offer learning opportunities and responsibility to Undergraduate Brothers, who otherwise might never have had this kind of teaming opportunity.

The Extranet location also can offer a connected Web site, open to the public, that can be used to promote philanthropic activities, as well as our Brothers and the history of the House. Any information and image that the Brothers want to show to the University can be included to market our house to potential members, and control our public relations reports.

The site also offers the opportunity to put the Yon Clarion Bell primarily online, reducing the costs of printing and mailing to almost nothing. Brothers can either receive the report by e-mail, or an e-mail can notify them that the newest issue has been posted, and they should come to the site to read it. Brothers without Internet connections, can receive a printed version of the

# The first Robinson Scholar writes

Upon my return to the lush Pierce Memorial this past Spring to see off the brothers in the class of '98, I was amazed to find the new computer room. I spent the spring semester with Colgate's London Economics Study Group and, though it proved to be a completely unique and invaluable experience, I am truly glad to be home. The fall semester has been progressing well and things seem to be running very smoothly in the house. I think the computer center is a testament to the harmony between the Foundation, Corporation and Active Brotherhood. For me, the computer center seems to embody the future of our house as well. It will prepare DKE for the new millennium while retaining the values and traditions we hold so dear. In short, I applaud the work of yourself, Brother Wolfenden and Brother Guido for making this possible.

I am writing this letter because I would like to assume the responsibilities Brother Rubenstein performed this past spring and also expand upon them. I have spoken with him about this on several occa-

sions, and he is willing to help me through the transition. I am qualified to handle our machines and have a wide range of computer experience. For example, this summer I completed a hardware, operating system and networking course. I also have obtained a unique position on Colgate's campus network. I have secured a position as a system analyst for Information Technology Services (ITS) which will soon allow me to troubleshoot things like Brothers' e-mail problems directly. For these reasons, I believe I could be an asset as the DKE computer network analyst.

I am typing this letter on DKE #3. However, word processing is just one of the tasks these computers can do. This room has an enormous amount of potential, and I would like to help us realize it. I read Wired and Byte magazines monthly and have been keeping abreast of the interesting new software. For example, there is now voice recognition software to convert your words into computer text for less than \$50. I would be

happy to further research the viability of this type of software considering our needs. As part of this job, I would also be willing to scan DKE documents (such as the Yon Clarion Bell and valuable letters) into the computer or zip disks for permanent digital storage. Additionally there are many routine tasks to perform which eliminate clutter and retain efficiency. I have already downloaded updates to our virus protection software so that our computers stay bug-free.

I understand that there is a possibility of a scholarship for this work or as being a paid position. I hope that some compensation is a reasonable request, if I spend a considerable amount of time working here.
